Dr. Guerra stated that Pharmacy students interested in community pharmacy and independent practice should attend MRM, because it is the one place entrepreneurial minded students can connect with others, and build businesses before they graduate pharmacy school. Students interested in entering the next competition, should watch myFacebook page, TonyPharmD, around MRM time.

Ms. Moultry participated in making some of those connections. She stated that she met a lot of student pharmacists and participated in several events such as workshops, and collaborative brainstorming events to develop innovative ideas to implement within their individual APhA-ASP chapters and learned how she could maximize the Generation Rx Campaign. She attended the Leadership Training Series: 'Turning Passion into Action', hosted by Walmart that allowed her to connect with other student pharmacists to discuss different interest and plan strategies to work together and capitalize on those interests. She attended the 'Career Connection Opportunities Expo,' where she learned about different pharmacy residencies, industry fellowships, and postgrad opportunities. She connected with many directors of different programs. Lastly, she ended the afternoon by voting on new set of regional officers.

Ms. Moultry attended the Policy Proposal Forum that allow chapters to propose, debate, amend, and defend policy resolutions, on topics that they feel need stronger advocacy. Ms. Moultry presented PCOM APhA-ASP chapter policy for Standardizing Point of Care Testing, which passed due to her convincing presentation that received 23 supporting votes out of 26 total.

Ms. Moultry stated that "The APhA-ASP Midyear Regional Meeting was more than a moment for me. It was an opportunity that rejuvenated my passions, taught me a lot about what I want in my career, and produced long lasting friendships in pharmacy. Dr. Guerra wrote a book called Unicorn Jobs for Pharmacists, that introduces 125 pharmacy students and pharmacists in diverse pharmacy careers, including jobs that allow pharmacist to workfrom-home.


Pharmacy Students Collaborate to Aid Atlanta Mission



Meet Ruth Pierre (PharmD '22)


Class Chair
