1.0 Introduction

The Federal Student Right-to-Know, Crime Awareness, and Campus Security Act, as amended by the Violence Against Women Reauthorization Act of 2013, now cited as the "Jeanne Clery Campus Safety Act," herein identified as the "Clery Act," requires institutions of higher learning to prepare, publish, and distribute a report concerning campus crime statistics and security policies on an annual basis through appropriate publications, mailings, or computer networks to all current students and employees, and all prospective students and prospective employees upon request. This publication contains the annual report concerning specific campus crime and arrest statistics as well as information about campus policies and practices intended to promote crime awareness, campus safety, and security.

2.0 CRIME STATISTICS

In accordance with the guidelines established by the Philadelphia College of Osteopathic Medicine (PCOM) and pursuant to federal law, identified as the Jeanne Clery Campus Safety Act, all currently enrolled students, campus employees, and all prospective students and prospective employees are entitled to request and receive a copy of the Annual Security and Fire Safety Report (Clery Report).

The report contains crime statistics about specified Clery Reportable crimes/ incidents that have been reported to the Department of Public Safety and/or Campus Security Authorities over the past three years in which occurred either On-Campus, On Campus Housing Facility, Public Property or Non Campus Buildings or Property owned or controlled by the University.

Clery reportable statistics have been collected, analyzed and categorized by the Security Director's at each campus. All statistics have been included in this report to share an accurate picture of crime on each campus.

The report also contains policies and practices pertaining to campus security, crime reporting, alcohol and drugs, victims' assistance programs, student discipline, campus resources, community safety alerts, crime prevention, access to campus facilities/ properties, and personal safety tips. The report encourages the reporting of all crime occurrences. The report describes how and to whom to report crimes.

2.01 CLERY REPORTABLE CRIMES/REPORTING LOCATION AND STATISTICS

The Clery Act mandates the use of federal definitions for certain types of crimes. These crimes and their definitions are listed below:

CLERY CRIMES

- » **Murder/Manslaughter:** The willful killing of one human being by another
- » **Negligent Manslaughter:** The killing of another person through gross negligence.
- » **Robbery:** The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.
- » **Aggravated Assault:** An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.
- » **Burglary:** The unlawful entry of a structure to commit a felony or a theft
- » **Motor Vehicle Theft:** The theft of a motor vehicle or tampering of the ignition or steering column.
- » **Arson:** Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.
- » **Rape:** Penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.
- » **Fondling:** The touching of the private parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of their temporary or permanent mental incapacity.
- » **Incest:** Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
- » **Statutory Rape:** Sexual intercourse with a person who is under the statutory age of consent.
- » **Violence Against Women Act:** The Clery Act uses the following definitions for crimes defined under the Violence Against Women Act (VAWA).
 - » **Sexual Assault:** Any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent.
 - » **Domestic Violence includes felony or misdemeanor crimes of violence committed by:**
 - » A current or former spouse or intimate partner of the reporting party
 - » A person with whom the reporting party shares a child in common
 - » A person who is cohabitating with or has cohabitated with the reporting party as a spouse
 - » A person similarly situated to a spouse of the reporting party under the domestic or family violence laws of the jurisdiction in which the crime occurred; or
 - » Any other person against an adult or youth who is protected from that person's act under the domestic or family violence laws of the jurisdiction in which the crime occurred.
 - » **Dating Violence:** Violence committed by a person who is or has been in a social relationship of a romantic or intimate relationship with the victim.

- » **Stalking:** Engaging in a course of conduct directed at a specific person that would cause a reasonable person to fear for their safety or the safety of others or suffer substantial emotional distress.
- » **Hate Crimes:** The commission of any of the above listed crimes and the additional crime categories listed below that manifest evidence the victim was chosen because of the perpetrator's bias against the victim can be classified as a hate crime per The Clery Act.
- » **Larceny /Theft:** Includes, pocket picking, purse snatching, shoplifting, theft from building, theft from motor vehicle theft of motor vehicle part or accessories and all other larcenies.
- » **Simple Assault:** An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffer obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration or loss of consciousness.
- » **Intimidation:** To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct but without displaying a weapon or subjecting the victim to actual physical attack.
- » **Destruction/Damage/Vandalism or Property (except Arson):** To willfully or maliciously destroy, damage, deface or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.

CATEGORIES OF BIAS:

- » **Race:** A preformed negative attitude toward a group of persons who possess common physical characteristics, eg. color of skin eyes, and/or hair, facial features, etc. genetically transmitted by descent and heredity which distinguish them as a distinct division of humankind, e.g. Asians, Black or African American, Whites.
- » **Religion:** A preformed negative opinion or attitude toward a group of persons who share the same religious beliefs regarding the origin and purpose of the universe and the existence or nonexistence of a supreme being, e.g. Catholics, Jews, Protestants, Atheists.
- » **Sexual Orientation:** A preformed negative opinion or attitude toward a group of persons based on their actual or perceived sexual orientation. Sexual Orientation is the term for a person's physical, romantic, and/or emotional attraction to members of the same and/or opposite sex, including lesbian, gay, bisexual and heterosexual (straight) individuals.
- » **Gender:** A preformed negative opinion or attitude toward a person or group of person based on their actual or perceived gender (e.g. male or female)
- » **Gender Identity:** A preformed negative opinion or attitude toward a person or group of persons based on their actual or perceived gender identity, e.g. bias against transgender or gender non-conforming individuals. Gender non-conforming describes a person who does not conform to the gender-based expectations of society, e.g. a woman dressed in traditionally male clothing or a man wearing makeup
- » **Ethnicity:** A preformed negative opinion or attitude toward a group of people whose members identify with each other, through a common heritage, often consisting of a common language, common culture (often including a shared religion) and/or ideology that stresses common ancestry. The concept of ethnicity differs from the closely related term "race" in that "race" refers to a grouping based mostly upon biological criteria, while "ethnicity" also encompasses additional cultural factors.
- » **National Origin:** A preformed negative opinion or attitude toward a group of people based on their actual or perceived country of birth. The bias may be against people that have a name or accent associated with a national origin group, participate in certain customs associated with a national origin group, participate in certain customs associated with a national origin group, or because they are married to or associate with people of ascertain national origin.
- » **Disability:** A preformed negative opinion or attitude toward a group of persons based on their physical or mental impairments, whether such disability is temporary or permanent, congenital or acquired by heredity, accident, injury, advanced age or illness. Offenses must be reported according to their occurrence in the following Clery-reportable geographic locations, or geographic categories:
 - » **On-campus:** Any building or property owned, leased, or under the control of PCOM within the same reasonably contiguous area and used by PCOM in direct support of or in a manner related to PCOM's educational purposes.
 - » **On-campus residential facilities:** Residence halls or other PCOM-owned residences. These statistics are a subset of campus property statistics. During the reporting period, PCOM only owned the Meta Christy House on the main campus (Philadelphia). The facility is managed by a private management company.
 - » **Non-campus buildings or properties:** Any building or property owned or controlled by PCOM or a PCOM officially recognized student organization that is used in direct support of, or in relation to, PCOM's educational purposes, is frequented by students, and is not within the same reasonably contiguous geographic area of PCOM.
 - » **Public properties:** All public property that are within the campus, or located

immediately adjacent to and easily accessible from campus, including: thoroughfares, sidewalks, streets, lands, and parks (property not owned or controlled by the PCOM and not a private residence or business). Public property reporting areas identified by the PCOM are as follows:

- The PCOM main campus is located within the Wynnefield section of the city in the Philadelphia Police Department's 19th district.
- The Cambria Healthcare Center is located in the 39th District. The Lancaster

Healthcare Center is located in the Philadelphia Police Department's 16th District.

- PCOM Georgia is located within the jurisdiction of the Gwinnett County Police Department.
- PCOM South Georgia is located in the jurisdiction of the Moultrie Police Department.
- The area surrounding both the PCOM main campus and healthcare centers as well as the PCOM Georgia and South Georgia campus is both residential and commercial.

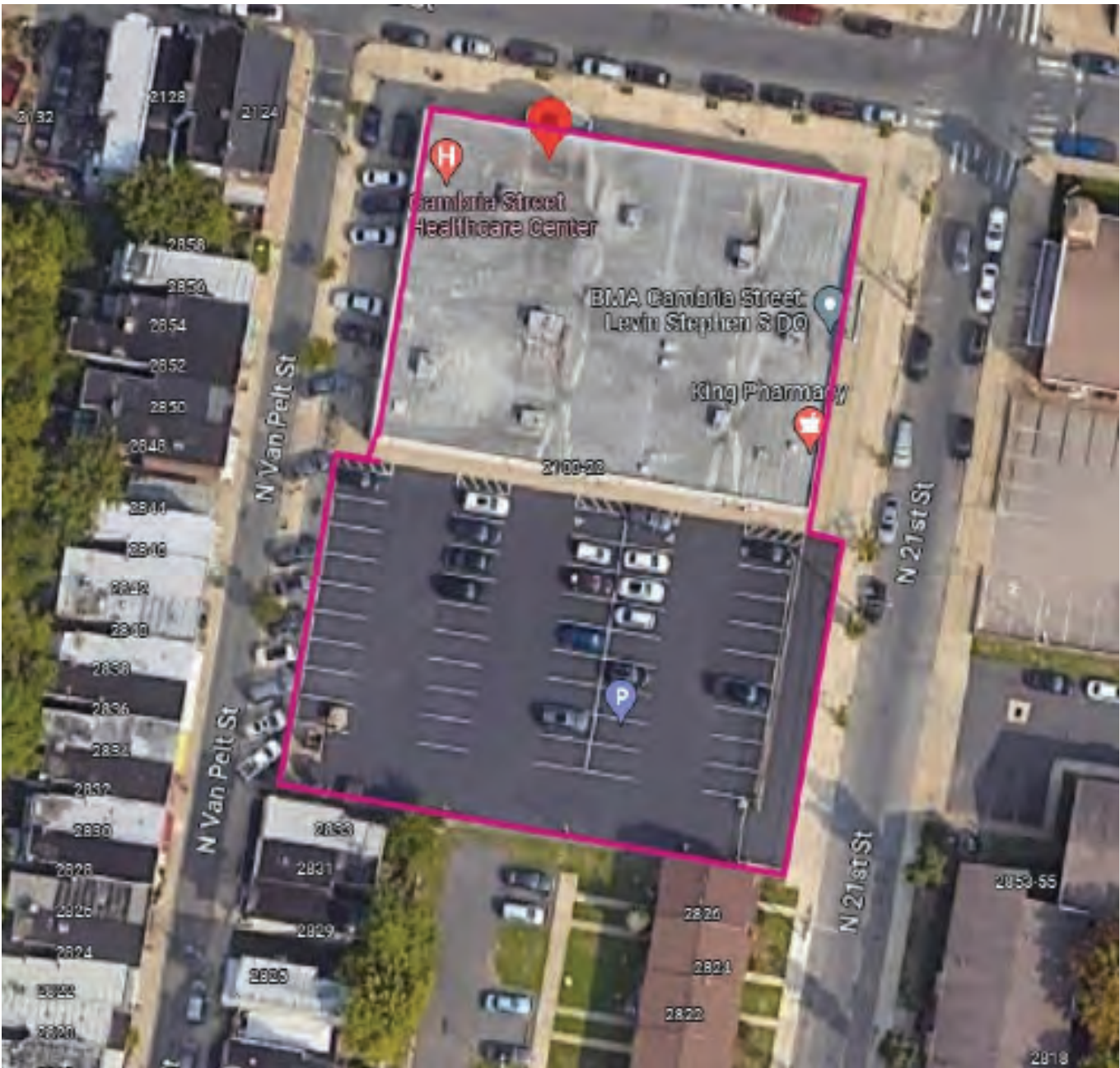
The Moultrie Police Department has jurisdiction over the PCOM South Georgia campus.

The campus boundary maps for each campus are depicted in the following:

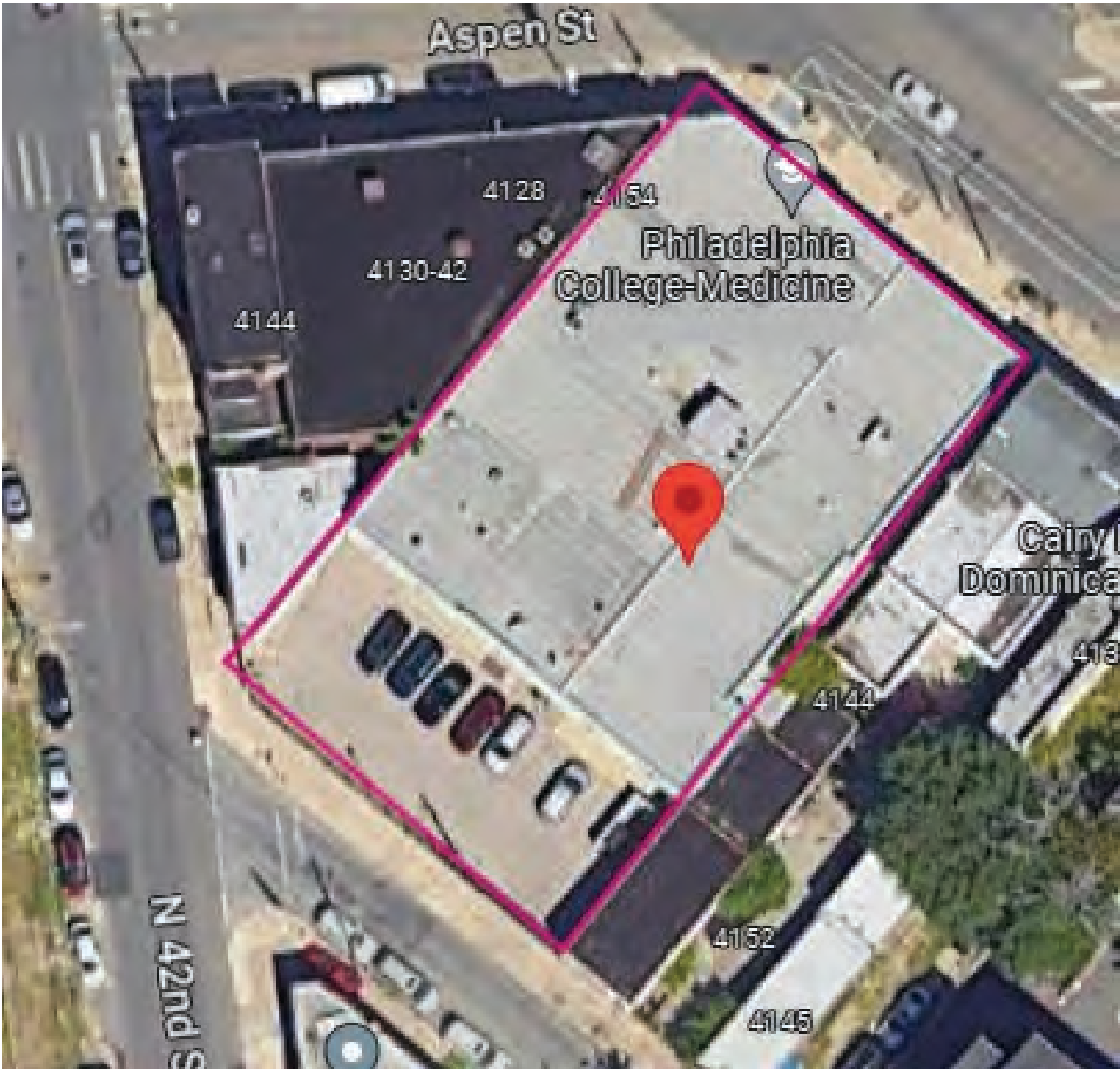

2.02 CRIME STATISTICS: PCOM CAMPUS

The 17-acre main campus of PCOM is located at 4170 City Avenue, Philadelphia, PA 19131 since 1968. The campus consists of six structures: Rowland Hall, Howard A. Hassman, DO '83 Academic Center, Levin Administration Building, Student Success Center, the Meta Christy House (residential facility) and a standalone six (6) level parking garage. On the eastern side of Monument Road is a surface parking lot and an athletic field.

PCOM leased multiple properties during the 2024 school year that were used for student housing. One (1) domestic violence incident occurred at 45 E Lincoln Avenue, Mount Vernon, New York. This incident has been included in the below statistics chart.

3.0 REPORTING CRIMES AND OTHER INCIDENTS

Security and public safety is a shared responsibility. All are encouraged to report crimes and suspicious activity to Public Safety immediately. To report a crime or incident, call 215-871-6351 or (X6911) on Main Campus or at the health clinics, 678-225-7451 (x7451) on Georgia Campus, or South Georgia Campus 229-668-3290 or (X3290). Dispatchers are available at these numbers 24 hours a day to answer your call. Immediate threats or events requiring emergency assistance should be reported directly to 911. However, if 911 is called first, Public Safety should be notified immediately afterwards so that Public Safety can assist the local law enforcement departments where the emergency is located.

Emergency “Blue Light” phones can also be used to report an emergency. Emergency phones are strategically located in various areas on all campuses. These phones are free standing and have a Blue Light located on top that does not require dialing. Press the large red button and wait for the Public Safety dispatcher to answer. The phones are equipped with an enhanced system that identifies your location for the Public Safety dispatcher.

In addition to reporting directly to Public Safety or the Campus Security Authorities, public safety concerns, including sexual misconduct, can be reported to EthicsPoint at 1-844-337-3613 or online at <https://secure.ethicspoint.com/domain/media/en/gui/52917/index.html>. You may also report sexual Misconduct at <https://www.pcom.edu/title-ix/>. These sites should not be used to report events presenting an immediate threat to life or property. Reports through these sites may not receive an immediate response. Events requiring emergency assistance should be directed to Public Safety or 911.

3.01 CAMPUS SECURITY AUTHORITIES

Although we encourage the reporting of crime directly to Public Safety, in some instances members of the campus community may choose to file a report with one of the other Campus Security Authorities (CSA). The campus security authorities include:

The CSAs work closely with the Department of Public Safety to ensure the safety of our community.

3.02 CONFIDENTIAL REPORTING

The Department of Public Safety allows for confidential reporting, except as required by law. Victims who do not want to pursue action within the University or the criminal justice system can make a confidential report on any crime. The University will guide victims through the available options and support the victims in their decision. Various counseling options are available at the University, and outside resources are available as well.



The purpose of such a report is to comply with the victim's wishes to keep the matter confidential, while taking steps to ensure the future safety of the victim and others. With this information, the University can keep and disseminate accurate records of the number of incidents involving students, determine where there is a pattern of crime with regard to a particular location, method, or assailant, and alert the community to potential danger.

3.03 INSTITUTIONAL RESPONSE

When an incident is reported, to the Department of Public Safety a member of the Public Safety Department, will be immediately sent to investigate. An incident report is generated and will be investigated accurately and promptly. The community is made aware of incidents that impact the entire community through the Philadelphia College of Osteopathic Medicine Emergency Notification System "P.E.N.S.". Emergency notification will be sent via email and text message. The Public Address system can also be utilized to inform the campus community of emergencies..

PCOM works cooperatively with the Philadelphia Police Department, Gwinnett County Police Department, Moultrie Police Department and the state police, as appropriate. PCOM Public Safety has an excellent working relationship with local law enforcement agencies.

Each campus maintains a Memorandum of Understanding (MOU) with its local law enforcement agency. The MOU outlines the respective responsibilities and expectations of both the law enforcement agency and the College. It also establishes the process for requesting and sharing crime statistics to ensure compliance with the Jeanne Clery Campus Safety Act.

These agreements are reviewed, updated as necessary, and executed

every two years to maintain effective collaboration and regulatory compliance.

3.04 STAFF AND FACULTY DISCIPLINARY REFERRALS

Regardless of criminal prosecution decisions, all criminal cases involving students are referred by the Department of Public Safety to the Chief Student Affairs Officer, Equal Opportunity and Access Manager, Title IX Coordinator or Chief Legal Affairs & Compliance Officer as appropriate. When there is evidence that a student has committed a crime on campus, disciplinary action at the University may proceed whether or not criminal charges involving the same incident have been adjudicated or dropped. The University does not have student organizations with off-campus locations.

3.05 TIMELY WARNINGS AND EMERGENCY NOTIFICATIONS

Timely Warning: When a Clery Act crime is reported and occurs in or on the institution's Clery geography; and the crime represents a serious and continuing threat students and employees. A timely warning must be sent to the campus community. The Public Safety Director is responsible for disseminating timely warning and emergency notification to their respective campus.

Before sending a timely warning the nature of the crime will be assessed and determine if a continuing threat exists to the campus community. A warning can also be issued for non-violent crimes, such as car thefts, burglaries, etc.

Emergency Notification: Once an imminent emergency is identified and confirmed by the Director of Public Safety or their Designee. The following steps will be taken:

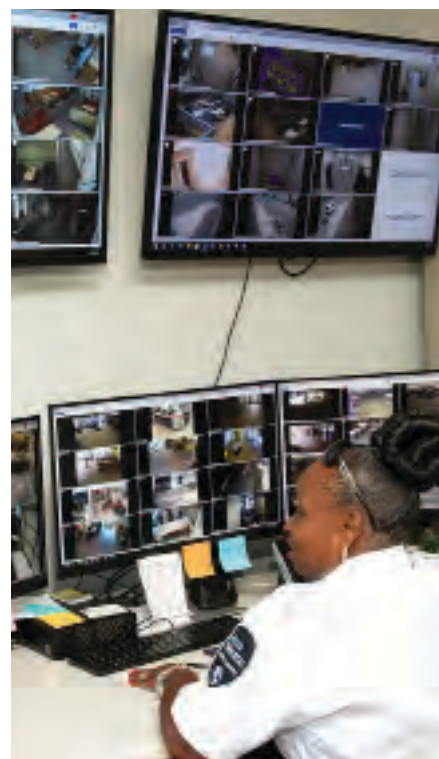
- » Alert the campus community through the public address system

- » Send an emergency notification using the PENS system
- » Security officer will provide guidance and directions to student, staff and faculty on campus

3.06 POLICE DAILY CRIME LOG

A daily log of all criminal offenses reported on the campus is maintained by the Department of Public Safety and is available online at <https://www.pcom.edu/about/departments/security/>

The Department of Public Safety may withhold information from the daily crime log if the release of such information would jeopardize an ongoing criminal investigation or the safety of an individual, cause a suspect to evade detection or flee, and/or result in the destruction of evidence.



4.0 PCOM SECURITY AND PUBLIC SAFETY DEPARTMENT

The mission of the PCOM Public Safety Department is to enhance the quality of life at PCOM by providing a safe and secure environment that is conducive to learning and is consistent with the educational goals of the institution, while building community partnerships that foster trust, mutual respect and cooperation.

The primary goal of the PCOM Public Safety Department is to protect life and property. The Public Safety Staff consists of three Directors; one (1) at the PCOM Campus in Philadelphia, one (1) at the PCOM Georgia Campus, and one (1) at the PCOM South Georgia Campus. There is one (1) Assistant Directors and one (1) Security Coordinator at the PCOM Main Campus. No member of the Public Safety team have arrest powers and their jurisdiction and authority are limited to the PCOM campuses and other PCOM owned properties.

Public Safety enforces the University's policies as well as assists local police authorities and enforcing Pennsylvania and Georgia state law and Federal law.

Philadelphia College of Osteopathic Medicine (PCOM) contracts with GardaWorld and Securitas to provide security services across its campuses. GardaWorld provides security services at the Philadelphia campus, while Securitas serves the Georgia and South Georgia campuses.

Security officers receive annual training in CPR, First Aid, the Jeanne Clery Campus Safety Act, and Title IX requirements applicable to higher education institutions. This training helps ensure that officers are prepared to respond effectively to emergencies, support campus safety initiatives, and comply with federal regulations. In addition, all security



personnel are Campus Security Authorities and have been trained as a CSA.

Security officers are stationed at building entrances and conduct both foot and mobile patrols of campus buildings and surrounding grounds. Dispatch personnel continuously monitor security cameras and emergency blue light stations in real time to enhance campus safety and facilitate rapid response to incidents.

Security officers are trained to respond to, observe, and report criminal activity, safety concerns, and hazardous conditions.

In addition, contracted security personnel are responsible for monitoring campus fire alarm and security alarm systems 24 hours a day, 7 days a week, ensuring a prompt response to emergencies and potential threats.

The Director of Public Safety at each campus oversees all contracted security services and supervises personnel within the Department of Public Safety. Each Director is

responsible for ensuring the effective delivery of campus safety and security operations, maintaining compliance with institutional policies and regulatory requirements, and coordinating security-related initiatives to support a safe and secure campus environment.

4.01 SECURITY AND FACILITY ACCESS

Public Safety also has responsibility for locking and unlocking campus buildings based on use, class schedule, and special events. Access to institutional facilities by employees is on an as-needed basis and incorporates strict key and access control procedures. All visitors must check in using the "Sine" visitor management system. Visitors must provide a form of identification, take a photo and provide their destination.

Each visitor will receive a visitor's badge that must be affixed to the outermost garment.

ACCESS CONTROL

The Department of Access Control is responsible for assigning building and room access privileges to faculty, staff, and students based on their roles and operational needs. The department manages the CCURE 9000 access control system, which serves all three campuses.

The CCURE 9000 system monitors access-controlled doors, duress alarms, and other security devices while providing centralized access management. The system also supports campus lockdown capabilities, enabling the institution to quickly secure facilities and enhance safety during emergency situations.

META CHRISTY HOUSE

All residents of Meta Christy House are issued a PCOM access badge.

The building remains secured and locked 24 hours a day, 7 days a week. A security officer is stationed at the front desk in the lobby at all times.

Officers are responsible for checking the photo identification of all visitors. Visitors must fill out a visitor pass through an online Google form. This submission requires first and last name, phone number, and a photo.

All visitors must be accompanied by the resident they are visiting. Visitors are not permitted to enter the building without the resident being present.

The main entrance is the only approved point of entry and exit. Rear doors are designated for emergency use only.



5.0 PREVENTION AND AWARENESS PROGRAMS

While crime prevention is a top priority of the Department of Public Safety, the department cannot protect everyone everywhere at all times. Thus, every member of the community is invited to partner with the department in this important effort. Together with other campus offices, the department provides programs to enhance personal safety, teach proactive crime reduction strategies and help community members develop personal safety habits, which contribute to a healthy community.

5.01 PREVENTION PROGRAMS

The crime prevention strategy rests on a multi-layered foundation of proactive area patrol of the campus, crime prevention education and training, and building and area security surveys. This approach relies on the dual concepts of eliminating or minimizing criminal opportunities, whenever possible, and encouraging community members to take responsibility for their own and others' safety.

Members of the Department of Public Safety are available to assist any individual or group in planning,

presenting and coordinating programs of interest or concern, or conducting safety and security seminars.

Philadelphia College of Osteopathic Medicine (PCOM) provides educational programming to prevent dating and domestic violence, sexual assault, and stalking. Educational programming consists of primary prevention and awareness programs for incoming students and new employees.

The programming includes:

- » Identifying what behaviors constitute domestic violence, dating violence, sexual assault, and stalking as prohibited conduct
- » The definition of consent
- » Information on reporting obligation
- » Provides information on risk reduction and bystander intervention
- » Provide information on reporting obligations, and grievance procedures
- » Provides information on rights and responsibilities
- » Provides information on the right and next steps when reporting for dating and

domestic violence, sexual assault, and stalking

- » PCOM's bystander intervention training is based on ACT, to Assess the situation, Choose your best action, and Take the action if you can

Information on risk reduction is provided so that students and employees can recognize concerns and how to potentially avoid certain situations.

These seminars can be tailored to service the geographical areas and meet the needs of the group. The service can be requested by contacting the Public Safety Department at PCOM at 215-871-6351, PCOM Georgia at 678-225-7451, and PCOM South Georgia 229-668-3290.

Procedures to Follow if a Crime of Sexual Assault, Domestic Violence, Dating Violence, or Stalking has Occurred:

- » Call 911 immediately
- » Contact the PCOM Department of Public Safety at
 - PCOM Campus
 - PCOM Georgia Campus
 - PCOM South Georgia Campus

PCOM provides the following rights for all parties involved in instances of sexual misconduct:

Know your rights. If you are involved in an act of sexual misconduct, you can expect the following:

- » Reasonable changes academic and living situations
- » Referrals to counseling
- » Assistance in notifying law enforcement
- » Opportunity to have others present at the disciplinary hearing



- » Notification of outcomes of hearing, sanctions, and terms of sanctions
- » Opportunity and assistance to speak (or choose not to speak) to anyone regarding the outcome
- » Name and identifying information kept private
- » Opportunity not to speak to law enforcement
- » Ability to have next of kin notified of outcome (should the complainant be deceased)

For all parties involved in matters involving sexual harassment (sexual assault, dating and domestic violence, stalking and sexual harassment), PCOM will protect the privacy of all parties. That includes excluding personally identifiable information from publicly available record keeping and reports. As well as privacy when it pertains to accommodations, supportive measures and protective measures, as long as the privacy does not impair PCOM's ability to provide such measures or accommodations.

The PCOM Sexual Harassment (Title IX) Policy 1.38 outlines definitions, reporting options and parties to report to, procedures and supportive measure information.

All PCOM parties involved with the processes outlined in the policy receive annual training as outlined on pcom.edu/title-ix.

Copies of the policy are available from the PCOM Equal Opportunity and Access Manager, Title IX Coordinator and PCOM Title IX Deputies. All parties involved with incidents of sexual harassment are provided our PCOM Title IX Support and Resource Guide which includes information on reporting options, rights, information on local medical care, options for supportive measures, and on-campus resources.

5.02 EDUCATIONAL PROGRAMS

All new students complete a mandatory training program through PCOM online learning platform, SafeColleges. This training consists of modules covering Campus Safe Act **VAWA**, Clery (Sexual Violence), Title IX Rights, Drug Awareness and Abuse, and Alcohol Awareness During student orientation. The Director of Public Safety provides information on Active Shooter and campus emergency protocols and procedures.

Returning students are provided similar topic education through an optional panel presentation, involving the Equal Opportunity and Access Manager, Title IX Coordinator representation from local law enforcement, local crisis centers and faculty.

Faculty and Staff are required to complete an annual, mandatory training program through SafeColleges covering Title IX and Sexual Harassment.

5.03 COUNSELING SERVICES

PCOM offers free student counseling services to all PCOM students through the Office of Student Affairs. This service offers students the opportunity to talk privately about personal, academic, or other concerns in a safe, confidential setting.

"Professional Counselors," such as the Personal Support Counselors at PCOM, are not considered to be Campus Security Authorities when acting in their professional capacity and are not required to report crimes for inclusion into the annual disclosure of crime statistics. PCOM does not require professional counselors to encourage clients to voluntarily and confidentially report crimes for inclusion in the crime statistics.

6.0 ALCOHOL AND OTHER DRUG POLICIES

It is the policy of PCOM to maintain an environment that is free of substance abuse by students, faculty and employees. The policy includes a prohibition against unlawful presence of controlled substances on campus, a prohibition against the unauthorized presence of alcoholic beverages on campus, and a prohibition against being under the influence of any controlled substance at off-campus classes, seminars or off-campus clerkships or internships.

When a student is suspected of being under the influence of alcohol or drugs, that student will be reported to the Student Affairs Director on their respective campus. Appropriate actions will be taken. This may include referral to counseling support programs, suspension or termination of enrollment at PCOM.

The Department Public Safety complies with federal, state and local laws including those which regulate the: manufacture, sale, purchase, transportation, possession and use of alcoholic beverages, controlled substances, and weapons. Regulations will be enforced by Public Safety and the local police departments.

The substance abuse policy is located in the College Policies Section of the Student Handbooks pamphlet.

6.01 AVAILABLE SUBSTANCE ABUSE SUPPORT

The University policy on drug and alcohol abuse represents the intent of the University to enable students to resolve substance abuse problems by requesting and receiving compassionate, confidential professional assistance.

In an effort to help our students and to protect patients and others from the harm that an impaired student may cause, PCOM's goals include:

- » Providing effective and compassionate assistance to the impaired student before irreversible harm is done to his/her health, educational process, eligibility for licensure, or ability to function competently upon graduation.
- » Providing a means by which the impaired student may request and receive confidential professional assistance without stigma or penalty, and thereby encourage self-reporting and personal responsibility.
- » Enabling the impaired student to confront his/her problem and, where feasible, receive effective therapy with minimal disruption of the student's education.
- » Establishing a process that focuses on counseling and therapy as

a front-line approach before disciplinary action is necessary.

If a student suspects impairment of another student, students should seek guidance from the Director of Student Affairs on their respective campus.

6.02 ALCOHOL AND DRUG ABUSE EDUCATION PROGRAMS

All new students complete a mandatory training program through PCOM online learning platform, SafeColleges. This training includes Drug Awareness and Abuse, and Alcohol Awareness. Returning students are provided similar topic education through an optional panel presentation.

The College provides educational programming regarding sexual harassment, dating violence, domestic violence, sexual assault and stalking.

These programs are relevant to the student body on each campus and include diverse communities and identities. Educational programming consists of in-person events and online-training. These also include on-going awareness and prevention programming.

The PCOM Sexual Harassment (Title IX) Policy 1.38 outlines definitions, reporting options and parties to report to, procedures and supportive measure information. All PCOM parties involved with the processes outlined in the policy receive annual training as outlined on [pcom.edu/title-ix](https://www.pcom.edu/title-ix). Copies of the policy are available from the PCOM Equal Opportunity and Access Manager, Title IX Coordinator and Title IX Deputies. All parties involved with incidents of sexual harassment are provided our Equal Opportunity & Access Manager and Resource Guide which includes information on reporting options, rights, information on local medical care options for supportive measures and on campus.

8.00 SEX OFFENDER REGISTRY AND ACCESS TO RELATED INFORMATION

The federal Campus Sex Crimes Prevention Act, which went into effect in October of 2002, requires that colleges and universities issue a statement informing the community where state law enforcement agency information pertaining to registered sex offenders may be found.

Megan's Law requires that the State Police establish and maintain a registry of individuals who have either been convicted of, pleaded guilty to, or were adjudicated delinquent of certain sex offenses, certain information on registered sex offenders to the public through

9.0 STOP CAMPUS HAZING ACT

The Stop Campus Hazing Act (SCHA) enacted on December 22, 2024 amends the Clery Act to prioritize the prevention of and transparency about hazing incidents at colleges and universities.

The term hazing for purposes of reporting statistics on hazing any incidents means intentional knowingly or reckless act committed by a person (whether individually or in concert with other person) against another person or persons regardless of the willingness of such other person or person to participate.

The Stop Campus Hazing Act requires all colleges and universities to post a Hazing Transparency Report twice a year and also to include hazing statistics in the Annual Security and Fire Safety

Report beginning in 2026. Hazing prevention programs and tips will be available to students, faculty and employees. All Pennsylvania and Georgia hazing laws will be followed.

Philadelphia College of Osteopathic Medicine will publish its first Hazing Transparency Report on December 15, 2025, and commits to publishing it every six months to meet its biannual publication requirements.

PCOM HAZING POLICY

All acts of Hazing are prohibited at PCOM. The Hazing policy applies to all organizations and their events, whether they or their event is located or the conduct occurs on or off the College campus. Hazing by any organization or group or its members is absolutely prohibited as in the Stop Campus Hazing Act of 2024.

Hazing includes: but is not limited to the following when performed in relationship to the foregoing purposes:

- » Ingesting food, drinks (including alcohol), drugs or other substances:
- » Acts of a physical nature. such as: beating, bonding, branding, calisthenics, exposure to outdoor elements, paddling striking, throwing items at or on a person, and/or whipping
- » Acts that adversely affect the mental health or dignity of the individual, such as: social isolation, kidnapping, abandonment, verbally berating and/or food or sleep deprivation:
- » Acts that a reasonable person would view to be frightening, humiliating, intimidating or deceptive, such as blindfolding,

personal servitude, designating entrances/exits to public spaces, requiring individuals wear uncomfortable, scant, or no apparel a designated time:

- » Acts that violate College policies, or federal, state, or local laws, regardless of whether charges are brought: and
- » Acts that endanger or have the potential to endanger a student's academic or personal life (e.g., preventing attendance to academic, employment, or family matters).

Hazing does not include:

- » Reasonable and customary Student Organization trainings, contests or other events that are explicitly relevant to the mission of the organization and performed by all members: and
- » Lawful expressive activities permitted under the First Amendment of the United States. Hazing prevention training will be conducted annually through online Safe College that must be completed by students, faculty and staff.

10.0 MISSING STUDENT NOTIFICATION

If a member of the University community has reason to believe that a student is missing, it is a requirement to contact the Director of Public Safety immediately.

The Director of Public Safety or Designee will perform the following:

- » Inform the Director of Student Affairs that a student residing in On-Campus Housing has been reported as missing
- » Undertake an investigation in an effort to locate the student

- » Notify the local police department, if the student cannot be located within 24 hours
- » Notify the local police department if a student is reported missing where there are concerns for the protection of life or property regardless of the time frame.

If the student has been missing for 24 hours the Director of Student Affairs will contact the student's Confidential Contact. If there is no Confidential Contact the student's emergency contact will be contacted.

Students residing in On-Campus Housing can complete a Missing Student Residing on Campus Contact Registration form to identify a Confidential Contact. Students can submit or revise this form at any time.

Students are responsible for ensuring that the emergency contact information on file with the Registrar's Office is up to date.

The Registrar's Office is located in Rowland Hall, 2nd Floor Room 203.

Fire safety is a high priority at the Philadelphia College of Osteopathic Medicine. Fire and life safety system testing, fire safety inspections, fire drills, false alarm prevention activities, and fire safety information for students help to make on-campus student housing safer from fire. The following information comprises the PCOM Fire Safety Report required by 34 CFR 668.49 for each on-campus student housing location.

The Environmental Health and Safety Department (EHS maintains a combined Daily Fire Log of all reported fire incidents in the Meta Christy House.

It includes details of fire-related incidents including the incident type, date incident is reported, date and time of occurrence and location of each reported incident, as well as the disposition of the incident, if this information is known.

EHS posts fire incidents in the Daily Fire Log within two business days of receiving a report of an incident and reserves the right to exclude reports from a log in certain circumstances as permitted by law. The most current 60 days of information is

available by contacting EHS at occ-env-safety@pcom.edu. Requests for information older than 60 days must be directed to the Chief Environmental and Occupational Safety Officer.

11.2 DESCRIPTION OF EACH ON-CAMPUS STUDENT HOUSING FACILITY FIRE SAFETY SYSTEM (34 CFR 668.49(2) (8)(2))

The only student housing owned or operated by PCOM is the Meta Christy House located at 4001 Monument Road, Philadelphia, PA. The Meta Christy House accepted the first residents in May of 2021. The structure is protected by a wet pipe sprinkler system on all floors. Fire department suppression equipment has access to the west, south, and north sides of the structure. Portable fire extinguishers are located throughout the facility. A complete fire alarm system consisting of manual pull stations, audible voice/visible alarms, sprinkler water flow, and valve supervisory devices and duct smoke detectors (supervisory signal only has been installed. Single station local smoke alarms are located in all apartments. The

annunciator panel is located inside the front door of the facility.

11.3 FIRE DRILLS (34 CFR 668.49(2)(8)(3))

Fire drills are conducted at least biannually for each building on campus. The Department of Public Safety along with the Department of Environmental Health and Safety works with Plant Operations to identify and correct any fire, safety, or security hazards.

11.4 INSTITUTIONAL POLICIES ON PORTABLE ELECTRIC APPLIANCES, SMOKING, AND OPEN FLAMES IN STUDENT HOUSING, EVACUATION PROCEDURES, AND FIRE SAFETY EDUCATION (34 CFR 668.49(2)(B)(4-6))

PCOM policy bans both smoking and smokeless tobacco products completely on all PCOM properties. These include cigarettes, cigars, pipes and products such as electronic smoking devices. Fire Evacuation Drills are supervised and conducted by the Occupational and Environmental Safety Department

with support from The Department of Public Safety and Plant Operations at least annually in all campus buildings. Self-evacuation by all occupants is mandatory whenever the fire alarm system is activated. All students and employees are assigned mandatory fire safety training annually through the Safe Colleges training platform. PCOM does not have a published policy on electric appliances or open flames, however consultation on both topics is available from the Department of Occupational and Environmental Safety to address concerns.

11.5 REPORTING A FIRE (34 CFR 668.49(2)(B)(7))

ANY RESIDENT OF THE META CHRISTY HOUSE THAT SEES OR SMELLS SMOKE OR FLAMES, OR WHEN THE FIRE ALARM SOUNDS, SHOULD FOLLOW THE FOLLOWING PROCEDURES:

- » If you discover a fire, pull the manual fire alarm, if it hasn't already been activated.
- » Call 911 and give the location of the fire. Notify the Department of Public Safety at 215-871-6351 after 911 has been notified.
- » Fire extinguishers should only be used if you are trained to use them and only after the alarm has been pulled and 911 has been called.
- » Evacuate the building using the nearest stairwell. Do Not Use Elevators.
- » Make use of the nearest exit door to the outside of the building, doors marked for emergency should be used; a fire alarm is an emergency!
- » Once outside, move across the street or down the sidewalk, away from the building entrance.
- » Do not re-enter the building until the all clear is given by the fire officer in charge or University Public Safety personnel.personnel.

12.0 POLICY ON THE POSSESSION OF DANGEROUS ARTICLES

It is the policy of PCOM to provide a safe work environment for our students, faculty and employees. We are committed to providing a work and learning environment free from dangerous articles of any kind.

Possession of firearms or weapons on the PCOM campus is strictly forbidden. Faculty, students, employees or visitors may not possess or use firearms, ammunition, knives, stun guns, or weapons, gunpowder, fireworks, explosives, gasoline and other dangerous articles and substances on college property.

Normal laboratory materials are excluded from this policy when used in a laboratory setting. This policy applies regardless of any permits the student or employee may own.

An individual who violates this policy should be reported to the Public Safety Department on their campus. Violators will be subject to immediate dismissal and/or civil or criminal action.
